**PRESENTATION OF DELRAY DUNE'S 50<sup>TH</sup> ANNIVERSARY BOOK TO COUNCIL;** Carrie Hill, Delray Dunes HOA President, is make the presentation.

 a. CONSIDERATION OF SITE PLAN FOR 19 COUNTRY ROAD; The Purses, owners of the 19 Country Road, are requesting permission to install a 6-foot wall on the west side of their property (next to Park Page 1 of 3 LPA & Village Council Agendas: June 16, 2021 A) wrapping around with a 4-foot wall and gate across the front, to both shield their generator and increase privacy.

- b. CONSIDERATION OF SITE PLAN FOR 22 COUNTRY ROAD; The Country Club of Florida ("CCF") is seeking Council approval for a revision (the "Revision") to the previously approved renovation of the Pelican Grille dining facility and related cart parking. The original renovation plan included lounge seating and fire tables on the outdoor patio under the covered pergola. As construction began in April, and the interior design details were being finalized, CCF management determined that there was a need for more outdoor seating for diners to meet demand.
- C.
