## **ORDINANCE NO. 67**

AN ORDINANCE OF THE VILLAGE OF GOLF, FLORIDA RELATING TO INCREASING THE LOCAL COMMUNICATIONS SERVICE TAX RATE; PROVIDING FOR INTENT; PROVIDING FOR INCREASING LOCAL COMMUNICATIONS SERVICES TAX RATE; PROVIDING FOR NOTICE TO THE DEPARTMENT OF REVENUE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, during the 2000 Regular Session, the Florida Legislature passed the "Communications Services Tax Simplification Law", creating Chapter 202, Florida Statutes (2000); and

WHEREAS, section 202.19(2), Florida Statutes (2001), states municipalities may impose a local communications services tax at a rate of up to 5.1% for municipalities that have not chosen to levy permit fees, and at a rate of up to 4.98% for municipalities that have chosen to levy permit fees. These maximums rates do not include the add-ons of up to 0.12% authorized pursuant to section 337.401, Florida Statutes, for municipalities that choose not to levy permit fees, nor do the rates supersede conversion or emergency rates authorized by section 202.20, Florida Statutes, which may be in excess of these maximum rates; and

WHEREAS, the Village of Golf desires not to require and collect permit fees from any provider of communications services that uses or occupies municipal roads or rights-of-way for the provision of communications services.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA AS FOLLOWS:

SECTION 1. Intent

It is the intent of the Village of Golf to increase its local communications services tax rate as provided in section 202.19, Florida Statutes and since the Village of Golf is not requiring or collecting permit fees from any provider of communications services, it is also the intent to increase the local communications services tax under section 337.401 Florida Statutes, as amended, for the Village of Golf by an amount not to exceed a rate of 0.12%.

# SECTION 2. Increased Local Communications Services Tax Rate

The local communications service tax conversion rate established under section 202.20(1)(b), Florida Statutes, for the Village of Golf is 0.60%, which is less than the maximum rate of 5.1%. In addition, since the Village of Golf has elected not to require permit fees from any providers of communications services, the total rate for the local communications services tax as computed under section 202.20(1) and (2), Florida Statutes amended, for the Village may be increased by ordinance by an amount not to exceed a rate of 0.12%. Therefore, the local communications services tax for the Village of Golf is increased to 5.22%. This increased rate is to be effective January 1, 2005.

SECTION 3. Notice to the Florida Department of Revenue.

The Village of Golf directs that notice of the increased local communications services tax rate be provided to the Florida Department of Revenue on the appropriate DOR form on or before September 1, 2004, and that a copy of this Ordinance accompany the form.

SECTION 4. Severability.

The provisions of this Ordinance are declared to be severable and if any section, sentence, clause, or phrase of this Ordinance shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance but shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION 5. Effective Date.

The effective date of this Ordinance shall be immediately upon its passage by the Village of Golf Village Council.
