

ORDINANCE NO. 99

AN ORDINANCE OF THE VILLAGE OF GOLF, FLORIDA, AMENDING EXHIBIT "A" OF ORDINANCE NO. 93, "VILLAGE ELECTIONS CODE" BY REPEALING SECTION 4. ALONG WITH ITS TITLE AND READOPTING IT WITH A NEW TITLE, "CANVASS AND CERTIFICATION OF ELECTIONS"; PROVIDING THAT REMAINING SECTIONS OF THE "VILLAGE ELECTIONS CODE" SHALL REMAIN THE SAME AS PREVIOUSLY ADOPTED; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Village Council of the Village of Golf adopted a "Village Elections Code" as Exhibit "A" to Ordinance No. 93 on April 21, 2010; and

WHEREAS, Sec. 14. of Article III. of the Village Charter authorizes the Village Council to regulate the conduct of elections by ordinance; and

WHEREAS, the Village Council desires to now repeal and readopt Section 4. of the Village Elections Code in order to provide reference to the canvassing and certification of elections, which canvass shall include the Palm Beach County Supervisor of Elections, in lieu of its current reference to a Village board of electors and inspectors; and

WHEREAS, the Village Council of the Village of Golf, Florida, believes it to be in the best interests of the health, safety, and welfare of the citizens of the Village that the Village amend its elections code in conformance with the Florida Election Code and certain pronouncements by the Supervisor of Elections.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA THAT:

SECTION 1: Exhibit "A", "Village Elections Code", of Ordinance No. 93 is hereby amended by repealing Section 4. along with its title and readopting Section 4. with a new title "Canvass and certification of elections"; providing that Section 4. of the Village Elections Code shall hereafter read as follows:

SECTION 4. SUPERVISED BY BOARD OF ELECTORS. CANVASS AND CERTIFICATION OF ELECTIONS.

~~All general and special elections held in the Village shall be under the supervision of a Board of Election composed of the Village Clerk and as many inspectors as deemed necessary by the Village~~

~~Manager. The inspectors shall be designated or appointed by the Village Manager, be registered electors and serve on an as needed basis for all general and special elections. The inspectors shall be paid for their services in such amounts as are generally accepted for such services as determined by the Village Manager.~~

The Village Clerk or designee of the clerk along with the Supervisor of Elections or the designee of that office shall canvass and certify any annual or special election pursuant to the requirements set forth at Sec. 100.3605, *Florida Statutes*, and in conformance with any approved and effective agreement between the Village of Golf and the Supervisor of Elections. Additionally, the Village Council by resolution may provide that two Councilmembers, whose seats are either not scheduled to be voted upon or who are unopposed at the election being canvassed, may also be made members of the canvassing board.

Section 2: All ordinances or parts of ordinances which are in conflict be and the same are hereby repealed.

Section 3: Should any section or provision of this Ordinance or any portion thereof, any paragraph, sentence or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder of this Ordinance.

Section 4: Specific authority is hereby granted to codify this Ordinance.


Section 5: This Ordinance shall take effect immediately upon passage.




