ORDINANCE NO. 123

AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA, AMENDING THE VILLAGE'S COMPREHENSIVE PLAN BY AMENDING THE FUTURE LAND USE MAP TO DESIGNATE AN APPROXIMATELY +- 36.40 ACRE PARCEL OF PROPERTY WHICH IS GENERALLY LOCATED SOUTH OF WOOLBRIGHT ROAD AND IMMEDIATELY EAST OF MILITARY TRAIL AS HAVING A FUTURE LAND USE OF COMMERCIAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE REPEAL OF LAWS IN CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village Council of the Village of Golf, Florida (Village), has adopted a Comprehensive Plan pursuant to Chapter 163, Part II, Florida Statutes, formerly known as the Local Government Comprehensive Planning Act" and now known as the Growth Policy Act (the Act); and,

WHEREAS, the Florida Department of Community Affairs, now known as the Department of Economic Opportunity, has previously determined that the Town's Comprehensive Plan was "in compliance" with the Act; and,

WHEREAS, pursuant to Section 163.3174(4)(a) of the Act, the Village's Local Planning Agency (the LPA) has conducted a public hearing to consider an amendment to the Comprehensive Plan to change the future land use of the property legally described in the attached Exhibit A, which is incorporated herein (the subject property) from Agricultural to Commercial; and,

WHEREAS, The Village Council has determined that the assignment of a future land use of Commercial to the subject property would be in compliance with the Act; and,

WHEREAS, pursuant to Section 163.3184(11), Florida Statutes, the Village Council has conducted a public hearing to consider the *transmittal* of the amendment of the Future Land Use Map, and after considering public comments has authorized the transmittal of the amendment to the Office of Economic Opportunity pursuant to Section 163.3184(4)(b), F.S..

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA:

Section 1. The whereas clauses are incorporated herein as the legislative findings of the Village Council.

Section 2. The "Comprehensive Plan of the Village of Golf," is hereby amended to change the Future Land Use assigned to the subject property to Commercial as shown on the Future Land Use Map of the Village's Comprehensive Plan which is attached hereto and incorporated herein as Exhibit "B".

Section 3. The Village Clerk is hereby directed to *transmit* the required copies of this ordinance to the Department of Economic Development and all other parties pursuant to Section 163.3184(4)(e) 2., Florida Statutes.

Section 4. Severability. If any section, paragraph, sentence, clause, phrase or word of this Ordinance is for any reason held by a court to be unconstitutional, inoperative or void, such holding shall not affect the remainder of this Ordinance.

Section 5. Repeal of Laws in Conflict. All ordinances or part of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 6. Effective Date. The provisions of this Ordinance shall become effective pursuant to Section 163.3184(4) (e) 5, Florida Statutes.
