

RELATING TO EXTENSIONS FOR COMPLETION OF INTERIOR CONSTRUCTION WORK; PROVIDING FOR CONFLICTS, AND SEVERABILITY; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

ORDINANCE NO. 131

AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA, AMENDING THE VILLAGE'S COMPREHENSIVE PLAN BY AMENDING THE FUTURE LAND USE MAP TO DESIGNATE APPROXIMATELY ± 32.51 ACRES OF PROPERTY WITHIN THE VILLAGE FROM AGRICULTURAL TO AG RIC UL TURAUEQUESTRIAN AND AMENDING THE LAND USE ELEMENT TO REFLECT THE CHANGE TO AGRICULTURAUEQUESTRIAN; PROVIDING A CONFLICTS CLAUSE AND A SEVERABIUTY CLAUSE; AND PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.
