


NOTICE OF PUBLIC HEARING ON PROPOSED AMENDMENTS TO THE VILLAGE'S COMPREHENSIVE PLAN, AMENDMENTS TO LAND DEVELOPMENT REGULATIONS AND IMPLEMENTATION OF YEAR-ROUND LANDSCAPE IRRIGATION CONSERVATION MEASURES

Please take notice that the Village Council of the Village of Golf, as the Village Local Planning Agency (LPA) will make recommendations, and as the Village Council, will consider Ordinance No.136 on proposed amendments to the Village Comprehensive Plan to create Chapter 13, Property Rights Element, to amend Chapter 3, Transportation Element and to amend Chapter 5, Infrastructure Element, Chapter 6, Conservation Element, Chapter 8, Intergovernmental Coordination Element and Chapter 9, Capital Improvements Element, by adoption of a 10-Year Water Supply Facilities Work Plan. A Public Hearing will be held in person in the Village Council Chambers of the Village Hall Complex, 21 Country Road, Village of Golf, Florida and virtually (by Zoom) on January 26, 2022 at 9:00 a.m. by the LPA to consider and make recommendations as to Ordinance No.136, and as soon thereafter as may be heard, by the Village Council, for first reading of Ordinance No. 136, second and final reading of Ordinance 134, establishing the Village Architectural Review Committee, and second and final reading of Ordinance No. 135, establishing year-round landscape irrigation conservation measures.

ORDINANCE NO. 136

AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA, AMENDING THE VILLAGE'S COMPREHENSIVE PLAN BY CREATING CHAPTER 13, PROPERTY RIGHTS ELEMENT; AMENDING CHAPTER 3, TRANSPORTATION ELEMENT BY UPDATING VARIOUS PROVISIONS; AND AMENDING CHAPTER 5 INFRASTRUCTURE ELEMENT, CHAPTER 6 CONSERVATION ELEMENT, CHAPTER 8 INTERGOVERNMENTAL COORDINATION AND CHAPTER 9, CAPITAL IMPROVEMENTS ELEMENT BY ADOPTION OF A 10-YEAR WATER SUPPLY FACILITIES WORK PLAN; PROVIDING FOR TRANSMITTAL TO THE DEPARTMENT OF ECONOMIC OPPORTUNITY; PROVIDING A CONFLICTS CLAUSE AND A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

ORDINANCE NO. 134

AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF AMENDING THE VILLAGE LAND DEVELOPMENT REGULATIONS BY ADDING SECTION 10.15 TO ESTABLISH AN ARCHITECTURAL REVIEW COMMITTEE, AMENDING SECTION 10.07 (DEVELOPMENT SITE PLAN REVIEW) TO REQUIRE REVIEW OF BUILDING DESIGN ELEMENTS BY SUCH COMMITTEE AND AMENDING SECTION 1.05 (DEFINITIONS); PROVIDING A CONFLICTS CLAUSE AND A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

ORDINANCE NO. 135

AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, FLORIDA PROVIDING FOR LOCAL IMPLEMENTATION OF THE MANDATORY YEAR-ROUND LANDSCAPE IRRIGATION CONSERVATION MEASURES RULE OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT (40E-24, F.A.C.); PROVIDING DEFINITIONS; PROVIDING FOR THE APPLICABILITY OF THE ORDINANCE; PROVIDING THE LANDSCAPE IRRIGATION SCHEDULE; PROVIDING EXCEPTIONS TO THE LANDSCAPE IRRIGATION SCHEDULE; PROVIDING FOR A REQUIREMENT TO OPERATE TECHNOLOGY THAT INHIBITS OR INTERRUPTS AN IRRIGATION SYSTEM DURING PERIODS OF SUFFICIENT MOISTURE; PROVIDING FOR VARIANCES FROM THE SPECIFIC DAY OF THE WEEK LIMITATIONS; PROVIDING FOR ENFORCEMENT OF THE ORDINANCE; PROVIDING FOR PENALTIES FOR VIOLATION OF THE ORDINANCE; PROVIDING FOR CONFLICTS AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

These Ordinances may be inspected by the public on the Village Website (www.villageofgolf.org). Attendance at this public hearing may be in person or virtual (by Zoom). All who are interested are encouraged to attend the Public Hearing and be heard either virtually by Zoom or in person. At this Public Hearing the Village Council will hear all comments and arguments in support or in opposition to the proposed amendments to the Village's Comprehensive Plan, the amendments to the Land Development Regulations, and implementation of the year-

round landscape irrigation conservation measures. Anyone desiring to appeal a decision of the presiding body on matters considered at this meeting or this hearing may need a record of the proceedings. They may need to ensure that a verbatim record is made, including the testimony and comments on which the appeal is based. The Village of Golf does not provide such a record.
