

ORDINANCE NO. 14

"AN ORDINANCE OF THE VILLAGE OF GOLF, PALM BEACH COUNTY, FLORIDA, ANNEXING CERTAIN ADJOINING LANDS TO THE TERRITORIAL LIMITS OF THE VILLAGE OF GOLF; DESIGNATING ITS CLASSIFICATION UNDER THE ZONING AND BUILDING ORDINANCE; DE-ANNEXING CERTAIN LANDS IN THE TERRITORIAL LIMITS OF THE VILLAGE OF GOLF; PROVIDING FOR THE EFFECTIVE DATE THEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH".

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF GOLF, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

Section 1. That upon petition of the Owners of the following described property, there be annexed to the territorial boundaries of The Village of Golf, the following described property:

The West three hundred and seventy-seven (377) feet of the Northeast quarter (NE 1/4) less the North three hundred and eighty-three (383) feet of said West three hundred and seventy-seven (377) feet of said Northeast quarter (NE 1/4) of Section 36, Township 45 South, Range 42 East, Palm Beach County, Florida.

Section 2. That by such annexation the aforesaid land shall be and become a part of The Village of Golf with the same force and effect as if the same had been originally incorporated in the territorial boundaries of the Village of Golf.

Section 3. That the annexed aforesaid land be designated and classified as agricultural.

Section 4. That upon petition of the owners the following described property be de-annexed and hereby is de-annexed from The Village of Golf, Florida, and by consent of the Village Council be and hereby is declared not to be within the territorial boundaries of said Village of Golf, Florida.

The North three hundred and eighty-three (383) feet of the Northwest quarter (NW 1/4) of Section 36, Township 45 South, Range 42 East, Palm Beach County, Florida.

Section 5. That, by the terms of Article III, Section 17, of the charter of The Village of Golf, Florida, this ordinance becomes effective when approved and subscribed by the five members of The Village Council and signed by the Mayor and the Village Clerk.

Section 6. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
