

ORDINANCE NO. 15

AN ORDINANCE OF THE VILLAGE OF GOLF, FLORIDA  
REQUIRING ANY PERSON EMPLOYED WITHIN THE  
VILLAGE OF GOLF TO REGISTER WITH THE SECURITY  
DEPARTMENT.

WHEREAS, it has been determined by the Village Council that an ordinance be adopted requiring the registration with the Security Department of all persons employed within the Village.

NOW, THEREFORE, be it ordained by the Village Council of the Village of Golf, Florida, that:

Section 1. Any person employed within the Village of Golf is required to register with the Security Department on commencement of employment.

Section 2. A registration card shall be issued to each person satisfactorily registering under Section 1 of this ordinance and such registration card shall be carried by the employee at all times while within the Village limits. In the event such registration card shall be lost or cannot be produced on reasonable notice, such person shall promptly re-register and secure a new card from the Security Department.

Section 3. No fee shall be charged for the issuance of a registration card and the cost thereof shall be borne by the Village.

Section 4. The Village Clerk shall determine eligibility or non-eligibility for issuance of a registration card to a prospective employee on the basis of criteria established by the Village Council. In the event a prospective employee fails to qualify for issuance of a registration card, that employee shall be denied access to the Village by the Security Force.

Section 5. It will be a violation of this ordinance for any employer (excluding vendors) operating any business or trade in the Village to permit any employee to work without having complied with the provisions of this ordinance. Lack of knowledge is no excuse and it is hereby expressly made a duty of the employer to ascertain whether or not the employee has complied with this ordinance. Any employer violating the provisions of this section shall be brought to the attention of the Village Council for consideration for exclusion.

Section 6. Registration of vendors shall be based on the frequency of visitation at the discretion of the Security Force. Vendors that are not registered shall be stopped on each entry for vehicle recording.

Section 7. That if any section, subsection, sentence, clause or phase of this ordinance, for any reason, is held unconstitutional, void or invalid, the validity of the remaining portions of this ordinance shall not be affected thereby.

Section 8. This ordinance shall become effective when passed on second and final reading and when signed by the Mayor and the Village Clerk.
